RC178 CONSTITUTION

#### RC180 GATESHEAD INTERNATIONAL STADIUM SAFETY CERTIFICATE

The Committee received a report providing an update regarding the implementation and review of Gateshead International Stadium (GIS) Safety Certificate.

Certificate 25A was updated and replaced by certificate 25B on 2 May 2017 and since then a number of improvements have been initiated to ensure that the requirements of the safety certificate are embedded into all elements of the operation of the facility.

The proposed amendment was outlined to the Committee as follows:

In order to ensure that Gateshead International Stadium can continue to attract and facilitate a wide range of events, an amendment is proposed to certificate 25B relating to clause 7(b);

The requirement of clause 7:

Unless a notified Safety Officer or Deputy Safety Officer, whose appointment has been notified to the Council, is present, the capacity of the sports ground will be zero for the specified activities, except for the following:

(b) that when the public is admitted to the sports ground for a specified activity

where the holder estimates less than 500 spectators will be admitted, the Holder shall ensure the attendance of a minimum of two safety stewards.

The Certificate Holder requests an amendment of 7(b) as follows:

An industry established risk assessment scoring matrix is used to determine the number of stewards required for a spectator event.

RESOLVED - that the Committee approved the amendments to Gateshead International Stadium General Safety certificate 25b Clause 7(b)

## RC183 GUIDANCE ON DETERMINING SUITABILITY OF APPLICANTS AND LICENSEES IN THE HACKNEY AND PRIVATE HIRE TRADES

The Committee received a report informing them of new guidance on determining the suitability of applicants and licensees in the Hackney and Private Hire trades.

Under the provisions of the Local Government (Miscellaneous Provisions) Act 1976, applicants for certain Hackney Carriage and Private Hire licences must be 'fit and proper', and that licensees must remain 'fit and proper' throughout the currency of their licence failing which their licence may be suspended or revoked.

The Act does not specify the criteria by which a person's fitness and propriety shall be assessed, however in 1992 the Home Office and Department for Transport issued joint guidance regarding the relevance of convictions to a person's suitability to be licensed. It is widely acknowledged that the 1992 guidance is outdated, and the Home Office and Department for Transport have been invited to formally withdraw it in light of the fact that there is an apparent and unjustifiable inconsistency between those Councils that continue to reply on the guidance and those that have implemented their own policies which invariably take a less lenient approach regarding matters of serious criminal conduct.

Gateshead Council last revised its policy in 2015, and has worked closely with the Local Government Association in respect of its best practice guidance – https://www.local.gov.uk/councillor-handbook-taxi-and-phy-licensing

On 26 April 2018 the Institute of Licensing published guidance which has been produced in conjunction with Lawyers in Local Government, the Local Government Association and the National Association of Licensing Enforcement Officers. It is hoped that Councils will use the new guidance as the basis of reviewing their existing policies or introducing new policies where they are currently relying on the 1992 guidance, to achieve a greater degree of consistency across the country – <a href="https://www.instituteoflicensing.org/NewsJobsArticle.aspx?NewsOrJob=news&NewsID=11318">https://www.instituteoflicensing.org/NewsJobsArticle.aspx?NewsOrJob=news&NewsID=11318</a>

#### **SUMMARY**

This report advises the Committee of an application on behalf of The Tanfield Railway, Gateshead, for the premises to be approved as a venue for the solemnisation of civil marriages and registration of civil partnerships.

#### **Statutory Context**

1. Premises may be approved as a venue for the solemnisation of marriages under the provisions of the Marriage Act 1949 and the registration of civil partnerships under the Civil Partnership Act 2004. Premises are approved for a three-year period, subject to their being seemly and dignified and to satisfactory public order, fire and health and safety checks.

#### **Application**

Tanfield Railway Ltd, Marley Hill Engine Shed, Old Marley Hill, Gateshead, NE16
 5ET

#### **Inspection and Consultation**

- 3. The premises have been inspected by the representative of the Strategic Director, Corporate Services and Governance and reviewed by the Service Director, Development, Transport and Public Protection. The premises satisfy the requirement to be a seemly and dignified venue for the proceedings in accordance with the Marriages and Civil Partnerships (Approved Premises) Regulations 2005. Consultative arrangements are set out in the appendix. There are no objections to the application.
- 4. Consultation has been carried out with Northumbria Police and Tyne and Wear Fire and Rescue Service they have no objections or comments regarding the proposal.
- Approval is recommended for marriages and civil partnerships taking place in: Andrews House (Maximum occupancy 45)
   The Engine Shed (Maximum occupancy 522)

#### **APPENDIX 1**

#### **Policy Context**

1. The proposal supports the vision for Gateshead as outlined in the Sustainable Communities Strategy and the Council's Corporate Plan, in particular supporting the building of cohesive and diverse communities.

#### **Background**

2. Premises may be approved as a venue for the solemnisation of marriages under the provisions of the Marriage Act 1949 and the registration of civil partnerships under the Civil Partnership Act 2004, in accordance with the Marriages and Civil Partnerships (Approved Premises) Regulations 2005.

#### Consultation

3. In accordance with the regulations, the application has been advertised in the local press. The councillors for the Whickham South and Sunniside ward have been consulted. There are no objections to the application.

#### **Alternative Options**

4. Premises meeting the criteria under the Marriages and Civil Partnerships (Approved Premises) Regulations 2005 and guidance issued by the Registrar General must be considered for approved premises status. There is no alternative to considering the application.

#### **Implications of Recommended Option**

- 5. **Financial Implications** The costs of processing the application and public advertisement are met from fee income. The Strategic Director, Finance and ICT, confirms that there are no financial implications arising from this report.
- 6. **Risk Management Implications** The Head of Communities and Environment has consulted with Tyne and Wear Fire Service, Northumbria Police and on building control for purposes of health and safety and public order. There are no objections to the application.
- 7. **Human Resources Implications** There are no human resources implications arising from the proposal.
- 8. **Equality and Diversity Implications** The approval of premises for the solemnisation of civil marriages and registration of civil partnerships provides opportunities for people to enter into secular, civil, proceedings in a location of their choice, rather than at the offices of the district registrar.
- 9. **Crime and Disorder Implications** The Head of Communities and Environment has consulted with Northumbria Police on matters relating to public order. There are no objections to the application.

#### 10. **Health Implications**

The approval of premises for the solemnisation of civil marriages and registration of civil partnerships increases the opportunities for couples to enter into legally recognised relationships, with their attendant benefits, which, support personal and social stability and contribute to wellbeing.

- 11. **Sustainability Implications** There are no sustainability implications arising directly from the proposal. Those attending at an approved premise would be likely to travel to the premises for a celebration of the event even if the marriage ceremony or civil partnership registration was to take place at a separate location.
- 12. **Human Rights Implications** The approval of premises for solemnisation of civil marriages and registration of civil partnerships provides opportunities for people to enter into secular, civil, proceedings in a building of their choice, rather than at the offices of the district registrar.
- 13. **Area and Ward Implications** Tanfield Railway Ltd is in the Whickham South and Sunniside ward. The ward members have been consulted on the application. There are no objections.
