RW52 PROGRESS ON RIGHTS OF WAY MATTERS

The Committee were advised that with regards to Legal Matters listed on the report items 9 and 11 should be at Committee for it's November meeting.

The Committee were advised of the following works undertaken between March 2022 and July 2022.

- Peth Lane, Ryton 84 Replacement of steps and revetment
- Leam Lane, Felling 44 Replace horse still and birdsmouth fence line
- The Strimming programme commenced in May 2022
- Marley Hill, Whickham 199 Installation of 3 way marker posts
- Winlaton / Barlow, Blaydon 48 replacement of 2 stiles, strimmed and way marker posts added
- Pennyfine Road, Lamesley 12 Reinstatement of the route.

The Committee were advised of the following planned work to be carried out on the Rights of Way Network between March 2022 and March 2023.

- Lamesley 72 Sections 6, 7 and 8, Kibblesworth Removal of restrictions and re-surfacing / drainage work
- Lamesley 69 Section 3, Wrekenton Removal of restrictions, update entrance and resurface
- Ryton 33 & 35 Crawcrook Installation of directional fingerposts following near completion of development

Gateshead 1 – Harlow Green – Resurfacing

The Committee were advised of areas of the Rights of Way which have been highlighted as having ASB / Motorbike Issues

- Blaydon Burn on-going motorbikes issues, the police are aware.
- Marley Hill St Cuthberts Road, Marley Hill, Sunniside working with the landowner to improve legal access and signage to reduce trespassing and anti-social behaviour. Highlighting the issue of motorbike misuse with the police/community safety officers
- Whitehills Leam Lane Whitehill Drive ongoing motorbike misuse and fly tipping. Area is currently having access restrictions installed and a new fence line.
- Hill 60 Crawcrook/ A695 Anti-social behaviour following the closure of a
 walked desire line between Hill 60 and the Story Home Development. The
 resident has had their new fence line ripped out and have been verbally
 abused as well as named on social media. This desire line is not recorded on
 Gateshead Definitive Map as a public right of way. All incidents have been
 reported to the police.
- Stampley Moss Farm Blaydon 50/Thornley Lane Several reports of users being attached by the landowner's dogs. All evidence has been forwarded to the police. This is ongoing

Concern was expressed that someone could potentially be seriously injured by a dog as several residents have approached their ward councillor regarding bites. It was noted that the police are aware and it will be brought to the attention of Gateshead Council's enforcement team for investigation.

Bridleway Whickham 62 in Derwent Walk

Country Park, Swalwell, Gateshead

Summary

This report relates to the proposed change to a public right of way in Derwent Walk Country Park.

Purpose of the Report

1) To seek approval of the Public Rights of Way Committee for the Proposal set out at paragraph 6 in this report.

Background

- 2) Bridleway Whickham 62 is indicated with a solid black line, as shown from Point A to Point C on the attached plan at Appendix 2 to this report.
- 3) The Definitive Statement states that the public right of way, "Continues north-west under Whickham BW 215; the Derwent Walk (dismantled railway) to Goodshield Haugh down a sunken track to dead end".
- 4) The section of Bridleway Whickham 62 that is under Whickham 215 (dismantled railway) is now blocked by an embankment as the underpass has been filled in. This would have occurred during the creation of the Derwent Walk Country Park.
- 5) The existing Bridleway Whickham 62, between Points A and B and shown with a black line on the attached plan at Appendix 2, has created a cul-de-sac in that it does not lead to anywhere but an embankment, which prevents access underneath Whickham 215 (dismantled railway), as shown at Point B on the attached plan. Therefore, there is no access from Point B to Point C. This effectively created two cul-de-sac bridleways either side of Whickham 215 (dismantled railway).

Proposal

6) Approval is sought from the Public Rights of Way Committee for the Proposal set out below: -

To extinguish Bridleway Whickham 62 from Point A to Point C on the attached plan at Appendix 2 to this report on the grounds that it is no longer needed for use by the public. It is not currently used by the public and will not be used by the public in future as it is unsafe and inaccessible.

Land Ownership

7) The ownership of the land where the above Proposal is to take place if approved by the Public Rights of Way Committee is on Council owned land.

Legislation

- 8) Under section 118 of the Highways Act 1980, the Council has the power to extinguish a footpath, bridleway or restricted byway if it is expedient to do so, on the grounds that the path is not needed for public use. The Council will not be able to confirm an unopposed Order (if approved) unless it is satisfied that it is expedient to do so having regard to the extent to which it appears to the Council that the path (notwithstanding the making of the Order), would be likely to be used by the public and also having regard to the effect the extinguishment would have on land served by the path.
- 9) It is considered that the Proposal to extinguish Bridleway Whickham 62 satisfies this test because the public right of way is not currently used by the public and it is not needed because the public have access to other rights of way in the area.
- 10) Section 28 of the Highways Act 1980 provides for the Council to pay compensation where it is shown that the value of an interest in the land has depreciated, or a person has suffered damage by being disturbed in their enjoyment of the land. An "interest" for the purposes of section 28 of the Highways Act 1980, includes any estate in land or right over the land, whether that is exercisable by ownership, licence or agreement.
- 11) In relation to the proposed extinguishment of Bridleway Whickham 62, there are no known interests in the land that the proposed extinguishment would affect.

Consultation

12) No consultation has taken place.

Conclusion

13) In light of the embankment which has resulted in two cul-de-sac sections of Bridleway Whickham 62 and the fact that alternative routes have been created within the Derwent Walk Country Park, the Public Rights of Way Officer would recommend that it is expedient that Bridleway Whickham 62 be extinguished because it is unsafe for public use and not needed for public use now or in the future.

Recommendation

The Public Rights of Way Committee approves:

- i) That a public path extinguishment order be made to extinguish Bridleway Whickham 62 from Point A to Point C as shown with a black line on the plan attached at Appendix 2 to this report.
- ii) Grant delegated authority to the Strategic Director of Corporate Services and Governance to undertake the following:
 - a) To consult the statutory consultees and make a public path extinguishment order to extinguish Bridleway Whickham 62 from Point A to Point C, as shown with a black line on the attached plan at Appendix 2 to this report.
 - b) If no objections are received, to confirm the order or if objections are received and not subsequently withdrawn, to send the order to the Secretary of State for determination as an opposed order.



Summary

This report relates to the proposed change to a public right of way in Derwent Walk Country Park.

Purpose of the Report

1) To seek approval of the Public Rights of Way Committee for the Proposal set out at paragraph 4 in this report.

Background

- 2) Footpath Whickham 194 is indicated with a solid black line, as shown from Point A to Point B on the attached plan at Appendix 2 to this report.
- 3) The existing Footpath Whickham 194 has created a cul-de-sac in that it does not lead to anywhere. The alignment runs across Swalwell Visitor Centre Car Park and is blocked by several boundary fences which would have been erected when Derwent Walk Country Park was created over 20 years ago.

The Proposal

4) Approval is sought from the Public Rights of Way Committee for the Proposal set out below: -

To extinguish Footpath Whickham 194 from Point A to Point B on the attached plan at Appendix 2 to this report, on the grounds that it is no longer needed for use by the public. It is not currently used by the public and will not be used by the public in future as it is unsafe and inaccessible on its current alignment.

Land Ownership

5) The ownership of the land where the above Proposal is to take place if approved by the Public Rights of Way Committee is on Council owned land.

Legislation

- 6) Under section 118 of the Highways Act 1980, the Council has the power to extinguish a footpath, bridleway or restricted byway if it is expedient to do so, on the grounds that the path is not needed for public use. The Council will not be able to confirm an unopposed Order (if approved) unless it is satisfied that it is expedient to do so having regard to the extent to which it appears to the Council that the path (notwithstanding the making of the Order), would be likely to be used by the public and also having regard to the effect the extinguishment would have on land served by the path.
- 7) It is considered that the Proposal to extinguish Footpath Whickham 194 satisfies this test because the public right of way is not currently used by the public and it is not needed because the public have access to other rights of way in the area.


