SUMMARY

This report advises the Committee of an application on behalf of the Saltwell Towers for the premises to be approved as a venue for the solemnisation of civil marriages and registration of civil partnerships.

Statutory Context

1. Premises may be approved as a venue for the solemnisation of marriages under the provisions of the Marriage Act 1949 and the registration of civil partnerships under the Civil Partnership Act 2004. Premises are approved for a three-year period, subject to their being seemly and dignified and to satisfactory public order, fire and health and safety checks.

Application

2. David Lindsay, Civic & Corporate Catering Manager has made application on behalf of Saltwell Towers, East Park Road, Gateshead NE9 5AX

Inspection and Consultation

3. The premises have been inspected by the representative of the Strategic Director, Corporate Services and Governance and reviewed by the Service Director, Development and Public Protection. The premises satisfy the requirement to be a seemly and dignified venue for the proceedings in accordance with the Marriages and Civil Partnerships (Approved Premises) Regulations 2005. Consultative arrangements are set out in the appendix. There are no objections to the application.

APPENDIX

Policy Context

1. The proposal supports the vision for Gateshead as outlined in the Sustainable Communities Strategy and the Council Plan, in particular supporting the building of cohesive and diverse communities.

Background

2. Premises may be approved as a venue for the solemnisation of marriages under the provisions of the Marriage Act 1949 and the registration of civil partnerships under the Civil Partnership Act 2004, in accordance with the Marriages and Civil Partnerships (Approved Premises) Regulations 2005.

Consultation

3. In accordance with the regulations, the application has been advertised in the local press. The councillors for the Saltwell ward have been consulted and the cabinet member with responsibility for safer stronger communities and culture has been advised. There are no objections to the application.

Alternative Options

4. Premises meeting the criteria under the Marriages and Civil Partnerships (Approved Premises) Regulations 2005 and guidance issued by the Registrar General must be considered for approved premises status. There is no alternative to considering the application.

Implications of Recommended Option

- 5. **Financial Implications** The costs of processing the application and public advertisement are met from fee income. The Strategic Director, Corporate Resources, confirms that there are no financial implications arising from this report.
- 6. **Risk Management Implications** The Service Director, Development and Public Protected has consulted with Tyne and Wear Fire Service, Northumbria Police and on building control for purposes of health and safety and public order. There are no objections to the application.
- 7. **Human Resources Implications** There are no human resources implications arising from the proposal.
- 8. **Equality and Diversity Implications** The approval of premises for the solemnisation of civil marriages and registration of civil partnerships provides opportunities for people to enter into secular and civil proceedings in a location of their choice, rather than at the offices of the district registrar.
- 9. **Crime and Disorder Implications** The Service Director, Development and Public Protected consulted with Northumbria Police on matters relating to public order. There are no objections to the application.

10. Health Implications

The approval of premises for the solemnisation of civil marriages and registration of civil partnerships increases the opportunities for couples to enter into legally

recognised relationships, with their attendant benefits, which, support personal and social stability and contribute to wellbeing.

- 11. **Sustainability Implications** There are no sustainability implications arising directly from the proposal. Those attending at an approved premise would be likely to travel to the premises for a celebration of the event even if the marriage ceremony or civil partnership registration was to take place at a separate location.
- 12. **Human Rights Implications** The approval of premises for solemnisation of civil marriages enhances the right to marry under Article 12 of the European Convention on Human Rights.
- 13. **Area and Ward Implications** Saltwell Towers is in the Saltwell ward. The ward members have been consulted on the application. There are no objections.

- New Applications for Vehicles Over 3 Years Old to be Licensed
- Paul Dowling, Strategic Director, Communities and Environment

It is the Council's policy that when a vehicle is first registered with Gateshead Council as a Private Hire Vehicle or Hackney Carriage it shall be no more than three years old; and that the age of the vehicle will be determined as follows –

(i) if not previously used on a road anywhere in the world: date of first registration with DVLA(ii) if previously used on a road anywhere in the world (e.g. an imported vehicle): the date of manufacture.

This supports the Council's Climate Change Strategy, which states that one of its priorities is the provision of high quality green transport options and the promotion of their use; including by "Seek[ing] to increase levels of investment in public transport" (priority 4 key action 21 - http://www.gateshead.gov.uk/DocumentLibrary/Environment/Strategies/ClimateChangeBooklet2010.pdf).

The Council's Constitution states that the Regulatory Committee may to grant licences for Hackney Carriages and Private Hire Vehicles where the application does not meet the Council's standard conditions, but having regard to all relevant information, it is determined that the individual circumstances justify deviation from policy.

The Committee is requested to consider the attached report on applications for vehicles that are over the age of three years to be licensed as Private Hire Vehicles / Hackney Carriages.
