#### 1. PURPOSE OF THE REPORT

The Sub-Committee is asked to consider the application from Penny Petroleum Partnership 2 to vary the premises licence for Rapid Service Station, Durham Road, Harlow Green, Gateshead, NE9 7TD.

### 2. BACKGROUND

### The Application

The application submitted by Penny Petroleum Partnership 2 ('Applicant') to vary the premises licence for Rapid Service Station, Durham Road, Harlow Green, Gateshead, NE9 7TD is attached at Appendix 1.

The variation application that has been submitted seeks to change the supply of alcohol hours to 24 hours in line with the opening hours of the premises.

#### **Licence history**

Penny Petroleum Partnership 2 applied for a premises licence for Rapid Service Station, Durham Road, Harlow Green, Gateshead, NE9 7TD on 26 February 2016. The application was for the supply of alcohol Monday to Sunday 00:00-23:59 hours and the provision of late night refreshment Monday to Sunday 23:00-05:00 hours.

Representations were received by Northumbria Police, the Licensing Authority and Public Health. Following a mediation meeting agreement was reached about the licensable activity hours and conditions and therefore a premises licence was granted from 19 April 2016.

The times the Premises Licence authorises the carrying out of licensable activities are:

For the supply of alcohol:

Monday to Sunday 06:00 – 23:00 hours

For the provision of late night refreshment:

Monday to Sunday 23:00 – 05:00 hours

On 21 July 2016 Penny Petroleum Partnership 2 applied to vary the premises licence to specify an Emma Jackson as the designated premises supervisor. Northumbria Police had no objections to this application.

On 11 September 2017 Penny Petroleum Partnership 2 submitted a further application to vary the premises licence to specify Carol Robson as the designated premises supervisor. Northumbria Police had no objections to this application
