## **Purpose of the Report**

1. The purpose of this report is to ask Cabinet to consider the tenders received for the following:

    - Lot 3 Carer Relief Gateshead Crossroads Caring for Carers, operating as Carers Trust Tyne and Wear, Gateshead
  - ii) that tenders received from the companies for each of the lots listed below, for the contract for the Provision of Direct Access Assessment, Shared Living, Semi-Independent Living, Supported Lodgings and Floating Support Services for Young People Aged 16 25, be accepted for a 36 month period

commencing 1 July 2018 with an option to extend for a further 2 x 12 month periods:

Lot 1 Direct Access, Assessment & Emergency Accommodation Unit - The Cyrenians Limited (Operating as Changing Lives)

Lot 2 Shared Living Supported Housing Service and Semi-Independent Living & Floating Support - Home Group Ltd

# **Contract for the Provision of Supporting Carers Together in Gateshead**

# **Policy Context**

1. The contract for the provision of Supporting Carers Together in Gateshead has been organised in accordance with the Council's Contract Procedure Rules.

## **Background**

2. The contract is being arranged on behalf of Care Wellbeing and Learning and Newcastle Gateshead Clinical Commissioning Group (NGCCG).

The contract is for a 60 month period commencing 2 July 2018.

The purpose of this contract is to provide an all age carers service in Gateshead. The aim of the Service is to keep carers informed, support carers to look after their health and wellbeing, offer carers a break from caring and raise awareness of the role of carers

The contract will be divided into 3 Lots:

Lot 1 - Young Carers Service

Lot 2 - Adult Carers Service

Lot 3 – Carer Relief

The estimated annual value of the contract is:

#### Consultation

3. Consultation has taken place with carers, providers and stakeholders to understand the needs of carers in Gateshead and determine the best model for delivering carers services.

- Local Engagement Board (Newcastle Gateshead CCG) (July 2016)
- Parent/Carers of children with special educational needs and disabilities.
- Carers Health Needs Assessment completed by Public Health colleagues (September 2016)
- On-line survey via Gateshead Council consultation portal. (December 2016 January 2017)
- Engagement with Carers via drop-in sessions, in-depth interviews, prequestionnaires and arranged events. (January March 2017)
- Engagement with our Commissioned Providers to understand and map collectively both the current and future state of commissioning for carers (December 2016 – April 2017)
- Engagement with Care Management Teams (March 2017)
- Engagement with District Nurses (March 2017)
- Provider Engagement Events (July, August and December 2017)
