1. PURPOSE OF THE REPORT

The Sub-Committee is asked to consider the applications from Anna Tychmann to:

- Transfer the Premises Licence for Anna's Mini Market, 112 Eastbourne Avenue, Gateshead, NE8 4NJ from Renata Pappova to Anna Tychmann
- Vary the Designated Premises Supervisor for Anna's Mini Market, 112 Eastbourne Avenue, Gateshead, NE8 4NJ from Petr Maralik to Imran Alam

The applications have been brought before the Sub-committee due a representation /objection made by Northumbria Police.

2. BACKGROUND

The Application

The application submitted by Anna Tychmann ('Applicant') to transfer the premises licence for Anna's Mini Market, 112 Eastbourne Avenue, Gateshead, NE8 4NJ is attached at Appendix 1.

The application submitted by Anna Tychmann ('Applicant') to vary the Designated Premises Supervisor for the premises is attached at Appendix 1.1.

A copy of the Premises Licence is attached at Appendix 1.2. You will note that the premises was previously called Papp's Convenience Store.

Representation

Northumbria Police objected to both applications. They have stated that they believe should the Applicant become the Premises Licence Holder and Designated Premises Supervisor the licensing objectives would be undermined. The representation is attached at Appendix 2.

- d) A representative from Northumbria Police.

3. FOR CONSIDERATION

The areas for consideration by the Sub-Committee are:

- The application to transfer the Premises Licence for Anna's Mini Market, 112 Eastbourne Avenue, Gateshead, NE8 4NJ from Renata Pappova to Anna Tychmann
- The application to vary the Designated Premises Supervisor for Anna's Mini Market, 112 Eastbourne Avenue, Gateshead, NE8 4N from Petr Maralik to Imran Alam

4. THE POLICY & GUIDANCE

When carrying out its functions the Sub-Committee must have regard to:

- (a) the Statement of Gateshead Council's Licensing Policy, and
- (b) the Amended Guidance (April 2018) issued under Section 182 of the Licensing Act 2003 by the Secretary of State.

Some relevant parts of the Policy and Amended Guidance are reproduced in Appendices 3 and 4. The parties may refer to any part of the Policy and Guidance during the hearing.

5. FOR DECISION

The Licensing Authority may, having regard to the application, take any of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Grant either or both of the Applications; or
- Refuse the Applications.
