The licensing objectives of prevention of crime and disorder and protection of children from harm are not being upheld.

Grounds

On 13th February 2018 a member of staff sold four cans of lager to a 15 year old volunteer, contrary to section 146(1) of the Licensing Act 2003.

Northumbria Police found measures to promote the licensing objectives applied by the premises licence holder Shiv Kant (Jairath) to be inadequate. We have no confidence in the premises licence holder and his ability to achieve compliance with the Law and in particular the Licensing Act 2003.

I have been performing this role for 10 years. As a part of this role it is my responsibility to check licensed premise's compliance with the law and in particular Licensing Act 2003. At around 11:05hrs today 15th February 2018 Gateshead Council Licensing Officer Rebecca Sparrow and I visited Bensham News 247 Bensham Road, Gateshead, NE8 1UT to check compliance under the Licensing Act. The premises benefit from authorisation to sell alcohol off the premises. Premises licence no: 00CH01103. At the time of our visit the premises were open to the public and alcohol was on display. Present was a male who gave his name as Sudesh KUMAR dob.01/04/1941. He was the only person present and introduced himself as the uncle of the owner who he said was at the time at a cash and carry. He confirmed to LO Rebecca Sparrow his nephew was that listed on the premises licence as the premises licence holder Shiv Kant JERATH. Mr KUMAR also confirmed Mr JERATH's address was the same as that listed in the premises licence. I asked Mr KUMAR if he would now sell all groceries to which he replied "yes everything". I clarified this point by asking whether he would also sell alcohol if someone came in now and asked for it. His reply was "yes everything alcohol also". I noticed multiple notices above the counter referring to different policies on restricted sales. There were both Challenge 25 and Challenge 21 posters displayed. Mr KUMAR confirmed he knows not to sell to anyone who is not 18 but clearly did not understand Ch21 / 25 schemes. I asked him what he would do if someone intoxicated came in and asked for alcohol. He replied "No No I would not give it!". I then asked what he would do after. He did not seem to understand this question so I asked if he would record/write it somewhere that he refused the sale. He replied he would not and he would tell his nephew later. I asked whether he knew who the designated premises supervisor / the other manager was and he said he did not and that he only knew his nephew was there. Mr KUMAR was saying throughout our time at the premise that he would not know anything or where any paperwork would be as he only covers sometimes. He asked that we speak with his nephew and ask of him what Mr KUMAR could not locate the full premises licence nor could he produce any due diligence documents. The Licensing Authority (in its capacity as a Responsible Authority) have a number of concerns regarding this premises.

The designated premises supervisor is Anil Sandu. During a discussion with Mr Sandu he confirmed that he does not work at the premises and visits it once a week or once a fortnight. He said that he owns a business and has another premises.

The Council's Licensing policy states that the Council expect our DPS' to be at the premises at least 50% of their time. Mr Sandu stated that was aware that Mr Jerath who manages the store had tried to do the personal licence qualification but had struggled due to language difficulties.

The Licensing Authority visited the store on 15 February 2018 which was after the underage sale was made. At the time of the visit the individual behind the counter said he was only covering the shop whilst the 'owner' went to the cash and carry.

A specific example of the confused arrangements is shown in the attached photograph which shows a challenge 25 AND a challenge 21 policy being in place, which raises several issues but these concerns are heightened because the shop assistant at the time of the visit was unable to explain what a 'challenge' policy was at all.

He was also unable to operate the CCTV.

There is a concern that the already high levels of crime and anti-social behaviour may be worsened by the premises operating with ineffective management arrangement leading to the availability of alcohol to those who should not be sold it.

In light of these concerns enquiries have been made with the Local Community Safety Partnership. They have provided data to confirm that the area already suffers from very high levels of crime. It also highlights that violent crime is a particular issue and this is linked to alcohol in a number of

Gateshead Local Safeguarding Children Board (LSCB) is the body responsible for the protection of children from harm.

The LSCB is concerned that the licensable activities taking place at Bensham News are not in accordance with the promotion of another licensing objective, which is the protection of children from harm.

It has come to the attention of the LSCB that on 15th February 2018 a 15 year old child volunteer purchased 4 cans of lager from the premises during a trading standards test purchasing exercise.

Please provide as much information as possible to support the representation

LSCBs are the key statutory mechanism for protecting children from harm and agreeing how the relevant organisations in each local area will cooperate to safeguard and promote the welfare of children, and for ensuring the effectiveness of what they do.

Gateshead LSCB is made up of a number of statutory partners including Gateshead Council, Gateshead Health NHS Foundation Trust, Newcastle Gateshead CCG, North East Ambulance Service, Northumberland, Tyne and Wear NHS Foundation Trust, Northumbria CRC, Northumbria Police, Tyne & Wear Fire and Rescue Service and CAFCASS.

The protection of children and young people has always been a core commitment of all partners who work together in Gateshead to keep them safe.

Access to alcohol by young people and the resulting crime and disorder is a significant community problem that impacts on crime, and the fear of crime, within many areas of the Borough as well as being an issue that puts children and young people at risk themselves.

The vision of Gateshead LSCB is that every child should grow up in a loving and secure environment, which is free from abuse, neglect and crime, enabling them to enjoy good health and fulfil their social and educational potential. Evidence suggests that binge drinking in adolescence could limit opportunities for this to occur and therefore the LSCB is keen to ensure that licensees restrict access to alcohol by underage drinkers and have processes in place to ensure the protection of children from harm.

Research suggests that the adolescent brain may be uniquely sensitive to alcohol's effects due to the major changes in brain structure and function that occur during this developmental period. Studies have found that binge drinking by youths is also associated with alcohol-related violence and other anti-social behaviours.

A UK study found that binge drinking in adolescence was associated with an increased risk of health, social, educational and economic adversity continuing into later adult life. Alcohol intoxication can occur during binge drinking and the acute toxic effects are generally related to blood alcohol concentrations. There is evidence to suggest that the severe hypoglycaemia (low blood sugar) that can accompany alcohol intoxication and may result in coma occurs more commonly in adolescents than adults.

Deaths from alcohol poisoning appear to occur most often when relatively inexperienced drinkers consume very large amounts of alcohol in a short time.

This representation is made in my capacity as Director of Public Health for the Borough of Gateshead.

Since 2013 Directors of Public Health have been 'responsible authorities' under the Licensing Act 2003. The role of the Director of Public Health is to help promote the health and wellbeing of the local populations they serve. The Public Health approach to alcohol is to encourage and promote responsible drinking and protect young people from related harm. This is an expansive remit that influences a wide range of circumstances, including local licensing arrangements. Similarly, the licensing regime is concerned with the promotion of the licensing objectives, which collectively seek to protect the quality of life for those who live, and work in the vicinity of licensed premises, and those who socialise in licensed premises.

On 15th March 2018, a 15 year-old volunteer made was able to buy 4 cans of lager during a Trading Standards test purchase exercise. The sale was made by the uncle of the licence holder, who did not speak to the volunteer, except to ask for the money. There was no evidence the uncle, who works regularly in the shop, had received any training in under-age sales, and although a refusals register was maintained there was no evidence of the uncle refusing any sales.

I am particularly concerned that the arrangements to prevent underage sales are not sufficiently robust and therefore fail to protect children from harm. The sale to a minor demonstrates that the checks and balances in place are not rigorous enough and could also lead to a significantly heightened risk of proxy sales, due to the lack of care being taken to check the authenticity and age of the person buying the alcohol.


The sale of alcohol to children leads to a negative impact on the children that consume the alcohol and on those who live and work in the vicinity of the premises. Alcohol can have a significant impact on the health of young people and alcohol related harm remains one of the biggest health problems. Research suggests that alcohol can affect the developing brain in early adolescence, and this is also the age when some young people are particularly vulnerable to risk taking. The Healthy Child Programme (2010) states that 50% of adolescent binge drinkers are more likely to be dependent on alcohol or misusing substances when they reach the age of 30. Alcohol misuse in adolescence has been linked to poorer memory, increased risk of addiction in later life, impaired ability to understand the physical world. The Chief Medical Officer issues Guidance on the Consumption of Alcohol by Children and Young People- advising that an alcohol free childhood is the healthiest and best option. Public Health evidence suggests adolescents are less likely to try and avoid harm than any other age groups and therefore more likely to go on to binge drink and experience alcohol use disorders and therefore the Director of Public Health is keen to ensure that licenses restrict access to alcohol by underage drinkers and have processes in place to ensure the protection of children from harm.


The latest available data for alcohol related hospital admissions for young people under 18, shows that the rate is increasing for Gateshead (70.8 per 100,000) and are significantly higher than the England average (34.2 per 100,00, Public Health England 2014/15-2016/17).
