OBJECTION NOTICE TEMPORARY EVENT NOTICE

Date of event 16th June 2019 Time: 00:01hrs - 02:00hrs

Licensable activities: the sale by retail of alcohol

Northumbria Police, hereby give an objection notice to this Temporary Event Notice.

The notice seeks to cater for approximately 100 wedding guests who were previously partaking in the consumption of alcohol and other activities at a distant wedding venue. Further alcohol sales into the early hours of the morning will exasperate the potential for drunkenness, increase the risk for alcohol related incidents and public nuisance in and around the premises.

The public house does not offer smokers the opportunity to smoke inside the premises. We believe that local residents will be affected by noise generated by customers going outside in small hours of the morning for a cigarette break. Similarly, we fear noise and nuisance will be caused by customers leaving the premise at the end of the event.

We are concerned that all four licensing objectives will be undermined, should licensable activities be permitted under this Temporary Event Notice.
