The chief officer of police is concerned that the licensing objectives of 'the prevention of crime and disorder, the protection of children from harm, the prevention of public nuisance and the protection of public safety will be undermined, should licensable activities at this location be permitted as applied for.

The applicant wishes to:

- Provide late night refreshments between 23:00 and 05:00hrs daily both on & off the premises
- To add the retail sale of alcohol between 00:00 and 24:00hrs daily off the premises only

The premises are located in a residential area. There are other licensed premises in near vicinity offering both on and off sales and it is believed that the additional hours offering the sale of alcohol and provision of late night refreshment will draw already intoxicated patrons to the area exacerbating existing issues associated with crime, disorder and anti-social behaviour.

We note the premises are already subject to incidents reported to police. The majority of incidents at this address can be attributed to theft shoplifting.

We believe the steps the applicant identified in support of the promotion of the licensing objectives are not adequate for the proposed business operating model.

We would like to draw attention to section 11. of Gateshead Council's Statement of Licensing Policy referring to a Designated Premises Supervisor. The proposed DPS resides in Sheffield some 2.5hrs car journey away from Crawcrook.

"11.3 It is expected that a Designated Premises Supervisor will have day to day responsibility for running the premises and will be present at the premises at least 50% of the time in a seven day week that the premises are open for the carrying on of licensable activities."

It is to be noted that a premises licence belonging to United Co-operatives Ltd is already in existence at this location. We have no confirmation by the current premises licence holder that they intent to surrender this licence. For the purpose of this matter, the applicant Rontec Watwford Ltd

is viewed as a separate entity. There is therefore a possibility that two premises licences will coexist underpinning two different management structures and operating models. The existence of the two premises licences does not offer clarity around individual responsibilities with respect to the requirements under the Licensing Act 2003 and their accountability to the responsible authorities. Such situation is also predisposed to a conflict between individual operators. Consequently it is believed that in this situation the existence of two premises licences would undermine the licensing objectives.

Northumbria Police feels that the licensing objectives will be undermined should licensable activities be allowed to be carried out as proposed in this application.

This representation is made in my capacity as Director of Public Health for the Borough of Gateshead.

The Director of Public Health in Gateshead is concerned that the application for 24-hour alcohol sales at Crawcrook Service Station are not in accordance with the promotion of the licensing objectives.

Since 2013 Directors of Public Health have been 'responsible authorities' under the Licensing Act 2003. The role of the Director of Public Health is to help promote the health and wellbeing of the local populations they serve. The Public Health approach to reducing harms arising from alcohol misuse is to encourage and promote responsible drinking and protect young people from related harm. This is an expansive remit that influences a wide range of circumstances, including local licensing arrangements. Similarly, the licensing regime is concerned with the promotion of the licensing objectives, which collectively seek to protect the quality of life for those who live, and work in the vicinity of licensed premises, and those who socialise in licensed premises.

International evidence suggests that making it less easy to buy alcohol, by reducing the number of outlets selling it in a given area and the days and hours when it can be sold, is an effective way of reducing alcohol-related harm (NICE, PH24). Control policies in this area (regulating availability) reflect the theory that if alcohol is less easy to obtain, alcohol consumption and harm will decrease (Public Health England, 2016).

Rising consumption has been attributed to the increased affordability, availability and promotion of alcohol, along with a greater social acceptance of regular drinking and a tolerance of drunkenness. Increased availability of alcohol has come about through the progressive relaxation of the licensing regime. The contributory role that alcohol plays in a wide range of adverse social consequences is also increasingly recognised with links to crime, social disorder, fire fatalities, violence, domestic

violence, child neglect and work-related problems. Poorer populations and communities experience a disproportionately greater level of alcohol-attributable harm.

The time at which alcohol is available is rarely measured, however, it is recognised (PHE, 2016) that purchasing alcohol at 6.00am has different implications to purchasing for consumption at 6.00pm and it is acknowledged that longer serving hours cause greater alcohol related harm (PHE, 2016). A number of international studies have shown that each additional 1-hour extension to the opening time of a premises selling alcohol was associated with a 16% increase in violent crime (Rossow & Norstrom 2012) and a 34% increase in alcohol related injuries (de Goeij, Veldhuizen, Buster & Kunst, 2015). My concern with this application comes from the increase in hours of alcohol availability in a residential area that includes residential care homes in close proximity. There is a risk that the 24-hour sale of alcohol may draw people in from a wider area creating public nuisance, an increase in alcohol related crime, noise and leading to residents in the local area feeling unsafe. Children and older people are the groups most likely to be impacted by the increased availability, accessibility and visibility of alcohol related harm. This would have an impact through the night and also in the early morning and may result in an increase in alcohol related road casualties for both car drivers and pedestrians due to the risk of people travelling from outside of the local area to access alcohol at times where it is not available elsewhere.

24-hour sales will attract those early morning purchasers who are more likely to be alcohol misusers and may thereby contribute to antisocial behaviour such as street drinking. In fact, early morning drinking is considered one of the indicators for alcohol misuse (this is screened for within the AUDIT alcohol misuse screening questionnaire). Those who are alcohol-dependent drink regularly to keep any withdrawal symptoms away, drinking early, or first thing in the morning (to avoid withdrawal symptoms). However, due to their physical dependence they may not appear to be drunk and are served. However, they are still at serious risk of developing conditions due to heavy drinking (liver damage, cirrhosis, and cancers). The levels of wholly attributable hospital episodes for Gateshead are some of the highest nationally.

If the times of sale applied for in this application reflected the current availability for off sales in the locality there would be less impact on the likelihood of additional alcohol-related harm. The current availability in the ward is provided in the supplementary evidence. If the hours in this application were to be granted there would be 10 additional hours of off-sales alcohol availability, based on the opening times of other off-sales establishments in the area.

A number of international bodies, including the World Health Organisation, have recommended the control of hours of alcohol sales as a means to reduce alcohol misuse and alcohol related harms. (Stockwell & Gruenewald 2004; Popova et al. 2009)

I have concerns regarding the hours of alcohol sales requested and I would be willing to meet with the applicant to discuss licence conditions that we feel would help to satisfy the promotion of the licensing objectives in this locality. It is my view alcohol sales for these extended hours does not, and could never, promote the licensing objectives in any residential area of Gateshead.

## Please provide as much information as possible to support the representation (Please read guidance note 2)

The Director of Public Health objects to this licence application as it does not support the licensing objective, specifically the promotion of public safety, prevention of public nuisance and the protection of children from harm. The evidence suggests that the sale of alcohol during these extended hours would contribute to an increase in the level of alcohol related harm experienced in this ward.

The Crawcrook and Greenside ward does not have high levels of alcohol related harm in relation to some of the wards in the borough however in the vicinity of the service station there is a higher level of alcohol related harm compared to other parts of the ward directly adjacent to it. Our objection to the application for 24-hour alcohol sales is to protect the residents of this ward from the increase in harm that the evidence indicates will arise from an increase in the availability and accessibility of alcohol.

The harm experienced across Gateshead is highlighted in the following statistics:

- Gateshead currently has the 3<sup>rd</sup> highest rate of alcohol related admissions (persons, narrow) to hospital in England
- Since 2008/09 the rate of admissions to hospital for alcohol related conditions has increased by 25.4%
- Gateshead has the 2<sup>nd</sup> highest rate for alcohol related hospital admissions in the North East
- Since 2008/09 the rate of admissions to hospital for alcohol related conditions for females has increased by 33.2%. The projected trend is for this indicator to continue to increase.

My objection to this application is supported by the growing knowledge of the role of alcohol in a wide range of acute and chronic disorders, and a greater understanding of its negative social impacts. Licensing is and always has been a whole population intervention which should be employed to protect our population from harm.

According to estimates from Balance, alcohol related harm in Gateshead costs around £401 per head (taking into account costs to the NHS, crime and licensing, social services and the workplace). The cost per head across the North East is £386 and across England it is £363 per head.

In the Balance 2013 North East Alcohol Behaviour and Perceptions Survey 71% of responders in Gateshead thought it was completely unacceptable to buy alcohol from a garage forecourt.

Further supplementary evidence will be provided to support this representation.



New premises licence- Rontec Watford Ltd - Crawcrook Service Station, St Agnes Gardens, Crawcrook, Ryton, NE40 4NS

I refer to the above application and wish to object to the proposals on the grounds that I have concerns the Licensing objective of prevention of Public Nuisance will not be met.

The proposal for 24 hour opening/sale of alcohol will likely cause disturbance to local residents as garage is in immediate proximity of residential dwellings including vulnerable residents in the Addison Care Home. From experience of the area, the existing background noise levels in Ryton are very low at night and this would exacerbate the impact of noise from patrons/vehicles in the locality - potentially affecting residents sleep. It's most likely the business would be used beyond passing trade as I understand there is very limited provision of 24 hour off sales in the Northumberland region that could adversely impact residents in the Ryton area from repeated trade at night.

I wish to object on the grounds of

The prevention of crime and disorder

I believe that the increase of alcohol availability late at night at this location will increase the prevalence of ASB and crime. There is nowhere else locally with this type of late license and I believe it would lead to people congregating late at night in a residential area with housing very closely surrounding the garage. Public safety

As above, there will also be an increase of vehicle movements from distance who are travelling to get late night alcohol.

I am not sure of any other location in the vicinity with a similar license.

The prevention of public nuisance

Again- please see above. However I think it is important to stress just how close the houses are to this location, they wrap around the garage on three sides and are literally it's neighbours. There is also a residential home adjacent to the garage which is very close with vulnerable residents. It would cause a huge disturbance to have additional vehicles using the garage overnight.

The protection of children from harm.

Banardo's are currently investigating siting a children's home at the rear of the garage and this needs to be fully explored before any application should go ahead.

- There will be an increased level of noise due to traffic. The main road leading to Crawcrook filling station is very quiet after 10pm when the filling station closes as drivers will use the bypass and rarely drive through this part of the village at night.
- There will be an increased level of noise from customers using the service station between the hours of 22:00-06:00 when the service station is currently closed.
- There will be an increased risk of anti-social behaviour and alcohol induced violence near to the filling station due to being able to purchase alcohol after the local pubs close.

This would be detrimental to local residents and the environment. There is no need to have a 24 hour filling station in a small village as there are other fillings stations within 3.5 miles which are not next to a residential area. It is not necessary to supply alcohol at a filling station through the night when most users would be driving.

My objection to this application is based on a number of factors:
