#### 1. PURPOSE OF THE REPORT

The Sub-Committee is asked to consider the application Sajaad Ali for a new premises licence for 311-313 High Street NE8 1EQ following receipt of representations from Northumbria Police, Public Health Gateshead Council and Licensing Authority Gateshead Council.

# 2. THE APPLICATION

This report relates to an application by Sajaad Ali (The Applicant) for a new premises licence. The application is attached at Appendix 1.

The application for a new premises licence under s17 of the Licensing Act 2003 is for the supply of alcohol (off the premises only) at the following times:

Monday - Sunday 09:00 - 03:00

The application was advertised at the premises and in the local press.

# **Conditions**

The Licensing Authority may attach conditions to any licence which are appropriate for the promotion of the Licensing Objectives. A copy of the Model Pool of Conditions from Gateshead Council's Statement of Licensing Policy is attached as Appendix 1.1 that relate to the application.
