Northumbria Police are concerned that the licensing objectives and in particular the prevention of crime and disorder will be undermined should Taimour TAMKIN become the premises licence holder at Deckham Bargain Store, 111 Split Crow Road, Deckham, Gateshead, NE8 3SB.

Northumbria Police are concerned that the licensing objectives and in particular the prevention of crime and disorder will be undermined should Taimour TAMKIN personal licence no NCC00CJ3721 issued by Newcastle Council become the designated premises supervisor at Deckham Bargain Store, 111 Split Crow Road, Deckham, Gateshead, NE8 3SB.

Northumbria Police received information from the local authority that young people were obtaining alcohol from Deckham Bargain Store and subsequently carried out a joint under age sale test purchase operation during which Taimour TAMKIN failed to comply with requirements under the Licensing Act 2003.

On Saturday 24th April 2021Tracey Johnson Assistant Manager - Trading Standards & Licensing of Gateshead Council observed groups of youths in the area of the store carrying alcohol and subsequently youths coming out of Deckham Bargain Store with alcohol. She will say that one of the youths coming out the premises looked as young as 14-15years. Mrs Johnson will also say that Taimour TAMKIN was issued with an incident /refusal book by one of her officers earlier in the week but at this time the book was empty. Mrs Johnson will say that Taimour Tamkin could not operate the CCTV which appeared to be working at the time of her visit and offered advice on its use and purpose. Further investigation is underway concerning the said event/s of which further evidence may be supplied during any subsequent licensing sub-committee hearings.

Northumbria Police are in possession of further information relating to the premises that has come to light from staff at Longside House (children's home) that one of their residents is being served with alcohol at Deckham Bargain Store. It is believed this young person has been buying alcohol for themselves and other young people. The information relates to events around and including Tuesday 4th May 21. Further investigation is underway concerning said event/s of which further evidence may be supplied during any subsequent licensing sub-committee hearings.

On Friday 7th May 2021 Northumbria Police Officers and Trading Standards Gateshead Council carried out a test purchase operation when Taimour TAMKIN sold two bottles of alcohol to 15 year old volunteer. PC 3615 Murray issued Taimour TAMKIN with a £90 FPN.

During the time of this visit there were a number of young people entering the premises attempting to buy alcohol but could not get served as they had no ID. Youths said they were served in the past and TAMKIN knows them. One male even said to TAMKIN not to worry as he knows he is only not selling because the 'busies' were there. Taimour TAMKIN again failed to make any records of refusals although previously instructed to do so.

Officers identified CCTV system within the shop that appeared to be working. Officers requested to see footage from the CCTV, however TAMKIN refused claiming he did not have access to it and could not log on.

NP officers have seized the digital video recording (DVR) box and cautioned TAMKIN for the sale of alcohol to a person under the age of 18.

The combined impact of events occurring in and around the premises, the lack of regard for the licensing objectives & requirements under the Licensing Act 2003 and the disregard of advice given by responsible authorities' cumulatively amount to exceptional circumstances under which Northumbria Police places this objection to both the transfer of the premises licence to and the appointment of the designated premises supervisor Timour TAMKIN.
