I noticed the license review posted outside of the above mentioned shop and as a long time customer (over 10 years) I would like to make the following observations:-

- 1. I have personally seen the current proprietor request ID and refuse service to many people who appear underage on many occasions. The notice states that the licence is being reviewed for 'The protection of children from harm', which I believe is unfounded given the history of the establishment through all it's various owners in the past 10 years. I've also noticed that the current proprietor refuses to sell alcohol to anyone that he believes is incapable due to drink/drugs. If the selling to children was a common occurrence then this review application would have a point, but for only one instance being sighted, I believe even including those words on the notice is both unnecessary and possibly dangerous given the current obsession of the right wing with muslim men and young women.
- 2. When I spoke to the previous owner he advised me that without a drinks license he would not be able to continue. I understand that the current owner has attempted to diversify the shop however from my own experience when visiting the shop, usually 3 times a week, I believe that alcoholic sales still add up to a substantial amount of daily takings. I was under the impression that it is Gateshead MBC policy to promote local businesses not push people to use Supermarkets by causing the closure of more local community stores.

As a final sentence I would just re-iterate that after reading this notice justifying a review and providing only one instance of rule breaking seems more like overreach to me, surely a fine would have been the best way forward.
