We will give continuous consideration to preventing the undermining of the objectives. Promotion of the objectives will be enforced and supported by the Gatesheads statement of licensing policy. We will especially increase and enhance our resilience and determination to upholding the objectives on Friday late evenings / Saturday early mornings, Saturday late evenings / Sunday early mornings and (to a lesser extent) Sunday late evenings / Monday early mornings. In addressing the temporal profiles we have intentionally requested late opening and early closing allowing other like premises in the area to operate in a time zone that we do not wish to be associated with. We appreciate that alcohol creates complex social issues and a specific area of concern is that of adult family and friends purchasing alcohol on behalf of children or for delivery and consumption by children at home. We will work with the local police and engage with neighborhood PCSOs to identify those in the community who may commit such actions and will with assistance from this authority strive to refuse the sale of alcohol to chronic drinkers, and those associated with alcohol fueled crime and disorder, and domestic violence.

b) The prevention of crime and disorder

The prevention of Crime and disorder is a key concern to the operation of our business, as previously mentioned we appreciate that alcohol creates complex social issues and a specific area of concern is that of adult family and friends purchasing alcohol on behalf of children or for delivery and consumption by children at home. We will work with the local police and engage with neighborhood PCSOs to identify those in the community who may commit such actions and will with assistance from this authority strive to refuse the sale of alcohol to chronic drinkers, and those associated with alcohol fueled crime and disorder, and domestic violence. We have given great reliance and consideration to the Gateshead statement of licensing policy and are aware that the area of Gateshead is subject to a public space protection order. It is difficult to control consumption beyond the footprint of the shop but staff will with the use of CCTV and observations move on groups of individuals from the immediate area surrounding the shop, especially if they are consuming alcohol. Staff will verbally advise customers suspected of street drinking to take the alcohol home. Signs will be placed at the exit to support this. We therefore pledge to support the local PSPO, the licensing policy and this objective. Drunkenness is linked with disorder and staff will undertake an assessment of customers intending to purchase alcohol and will refuse any person who is drunk or of which there is a belief will intend to give the product to a drunk. Thirteen CCTV cameras are placed inside and outside of the shop. The three outside cover the surrounding footpaths to assist in identifying proxy sale transactions. There is a camera covering the door inside for facial recognition, and one over the till to ensure that the checking process and recording of refusals is followed. No alcohol will be sited near the main door and the cash point allows for a good view of the door and the proposed alcohol storage and display areas within the shop. The CCTV stores images for at least 28 days and is available for production to the relevant responsible authorities upon reasonable request. At this premises we operate Challenge 25, not just for alcohol but for all age related products that we sell. Refusals are recorded in our refusals register. This premises will provide off sales only and will not deliver alcohol. Vulnerability and safeguarding of customers is paramount and we will actively report any individual with whom we have concerns with in relation to substance misuse or sexual exploitation. As the applicant we are aware of and have regard to section 5.3 of Gatesheads Statement of Licensing Policy. The reduction of crime and disorder is integral to the operation of our proposed business. We will not conduct any promotions that encourage excessive alcohol consumption. We will provide lower alcohol and zero alcohol alternatives to our products.

c) Public safety

Aisles will be kept free of obstructions and the shelving will be free from protrusions. Any spillages will be appropriately signed and cleaned immediately. The premises has excellent illumination within and the step inside the door is well lit. CCTV is fitted both inside and outside the premises in the form of 13 cameras. Clear views are facilitated down each aisle. A fire risk assessment is in place and up to date. Three new fire extinguishers are within the shop and are maintained by an approved fire safety company. A smoke detector is cited central in the premises.

d) The prevention of public nuisance

The management at this shop actively promote and will enforce the recommendations contained within the Gateshead statement of licensing policy and in particular section 7.8 which interprets 'public nuisance' in its widest sense, and takes it

to include such issues as noise, light, odour, litter and anti-social behaviour, where these matters impact on those living, working or otherwise engaged in normal activity in an area.

13 CCTV cameras provide adequate footage both inside and outside of the premises. The images can be viewed from the pay point.

In considering section 10.4 of Gatesheads licensing policy this premises will not extend its opening hours outside of the framework applied for in this application, thereby reducing the impact on local residential premises.

We have restricted our opening times to cause as little as possible impact on any public nuisance, this decision was to limit impact on the residents nearby. We do not offer any form of regulated entertainment and there is no ambient background music within the shop. It is difficult to control consumption beyond the footprint of the shop but staff will with the use of CCTV and observations move on groups of individuals from the immediate area surrounding the shop, especially if they are consuming alcohol, even if not purchased at our venue. Staff will verbally advise customers suspected of street drinking to take the alcohol home. Signs will be placed at the exit to support this. We therefore pledge to support the local Public space protection order, the licensing policy and this objective. Litter will be collected from the perimeter of the shop and properly disposed of. External lighting is good but does not impact on residential premises.

Late night refreshment has not been requested and we do not provide hot food or drink prior to the 11pm regulatory time. This being said there should be no littering from foot papers or wrappers however we will ensure discarded litter is cleansed from the immediate front of the shop.

e) The protection of children from harm

The protection of children is paramount in our operation. We operate a challenge 25 policy for the sale of all age related products. Acceptable identification will be in the form of a valid in date Passport, Driving licence or card bearing the Proof of age standards scheme hologram. Any challenges which are refused will be recorded in the refusals register. Staff will be trained and conversant in the use of false or fake identification. Any traits or trends in the use of fake identification will be passed on to the local police for their information. A written record will be kept of all the names and addresses of persons who are authorised to sell or supply alcohol at all times, and that the written record will be made available to Police and/or Council officers immediately upon request.

This premise will provide off sales only and will not deliver alcohol.

Proxy purchasing is sadly common place and we will monitor potential customers using external CCTV and seek to identify individuals who are over 18yrs and attempting to purchase alcohol for under 18 yr olds. We will display a warning sign regarding proxy purchasing. Any traits or trends in proxy purchasing will be passed on to the local police for their information.

13 CCTV cameras provide adequate footage both inside and outside of the premises. The images can be viewed from the pay point.

We welcome partnership working with the local police and the sharing of intelligence in relation to any persons who persistently attempt to purchase alcohol, or individuals who buy on their behalf.

We do not provide any forms of adult entertainment.

Strict checking and challenging of under 25s will likewise occur should we operate the sale of lottery or scratch cards.

Vulnerability and safeguarding of young people is paramount and we will actively report any individual with whom we have concerns with in relation to substance misuse or sexual exploitation of both adults and children.

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

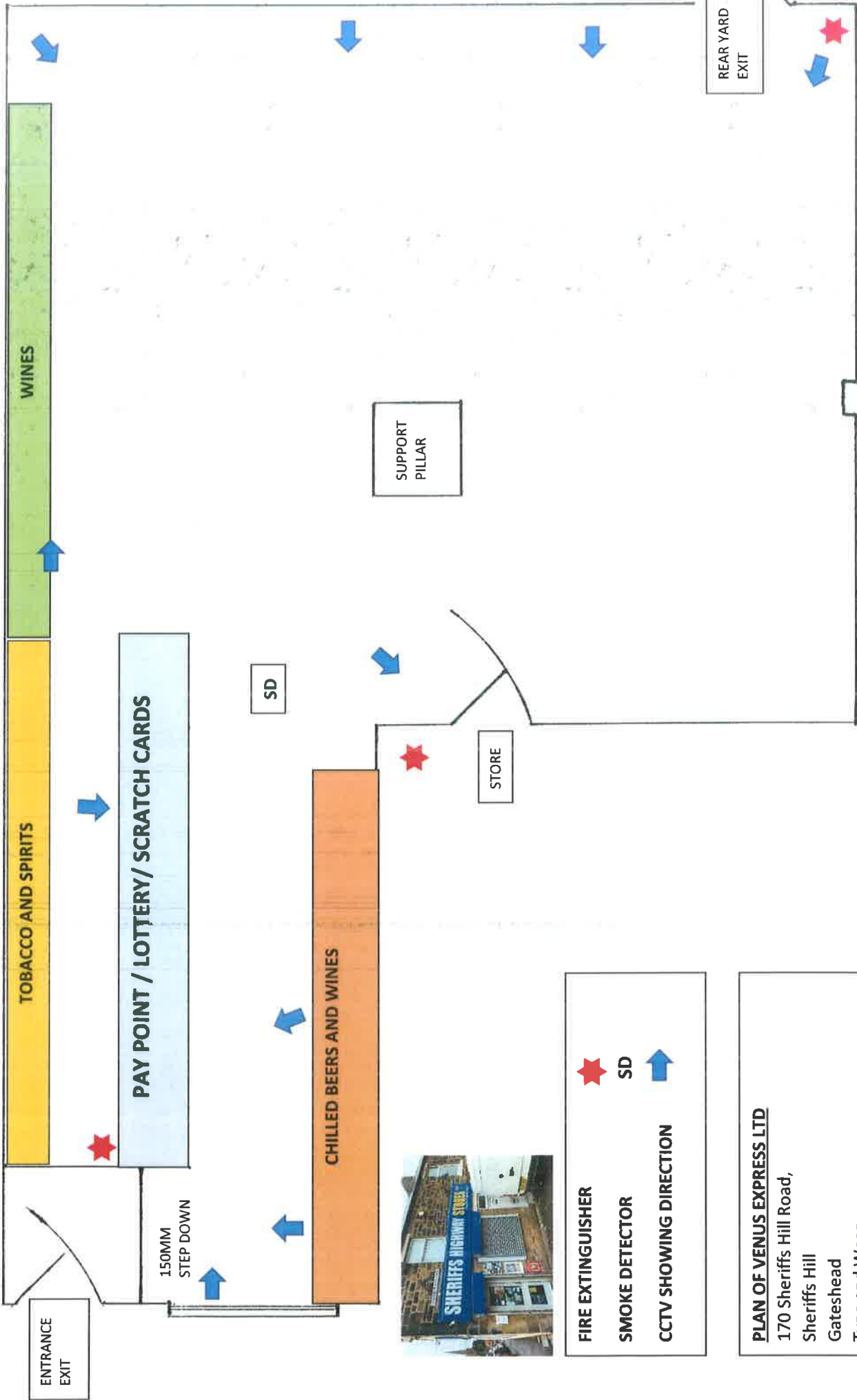
